What's SuperStream?

SuperStream is a Government initiative for processing superannuation data and payments electronically. It requires all employers to send super payments and employee information electronically in a standard format.

Why you should use QuickSuper

QuickSuper[^] will help you meet these SuperStream obligations, as well as make the whole contributions process easier and more efficient. And for all MTAA Super registered employers, it's accessible free of charge.*

One file. One transition.

If you're paying into multiple funds, you're probably dealing with many files and payments. By using QuickSuper, you'll only have one file and one transaction for all your payments. You just need to upload your data file (or enter your data directly online) and put your payment into QuickSuper. If the data and payments match, we'll distribute the contribution details and payments to all the super funds (both default contributions and choice contributions). The great thing is, you can log on at any time to see if your payments have been sent.
